

# Paddling Adventures

## Rental and Shuttle Service Agreement

1. Canoe, kayak and paddleboard rentals and use are at your own risk. Paddling Adventures, the Cape Leisure Corporation and its staff are not responsible for personal injury or loss of property.
2. Paddling Adventures will exercise the utmost care of private vessels and equipment during transportation, however, Paddling Adventures, Cape Leisure Corporation and its staff are not responsible for any damage to personal property.
3. Paddlers must meet Essential Eligibility Criteria. Person renting and/or acquiring shuttle service must be 18 years or older and at least one person within the group on the water must be 18 years or older.
4. All individuals renting a boat or SUP must have a wearable Type I, II, or III Personal Flotation Device (PFD) within quick reach in the vessel. Type IV (square cushion) flotation devices are not acceptable per USCG.
5. Florida law requires that children under 6 years of age **MUST WEAR** a Personal Flotation Device (PFD).
6. No motors of any type may be attached to canoes, kayaks or SUPs.
7. **Paddling Adventures will hold keys as part of the rental agreement.** Renter will be required to reimburse the Cape Leisure Corporation for all damaged or lost equipment. Cape Leisure Corporation has permission to hold personal items (keys) until resolved.
8. Cape Leisure Corporation has the right to refuse service to any guest if behavior is unsafe or inappropriate.
9. All guests (renters and passengers) are reminded that it is illegal to feed or harass any wildlife.
10. **All river trips end at 5:00 p.m. BE OFF RIVER BY 5:00 PM!**

**Please initial, indicating your understanding of the following statements:**

- Alcohol, tobacco products, disposable items of any kind, coolers and pets, are not permitted on the river. Staff may ask you to open any bags you may have to ensure adherence to this statement.
- RENTING WATERCRAFT: Renter is responsible for a **\$10.00 late fee** every 15 minutes per person if renter is not at their designated take-out location **by 5:00 PM.**
- SHUTTLE SERVICE ONLY: Shuttle Service only takes you from the South Entrance to the north canoe launch. It is your responsibility to get out at the correct location, where your vehicle is parked. (Extended Paddle includes return shuttle)

**Select your paddling trip:**

- Paddle Ichetucknee (3.5 miles)- North Canoe launch to South Take-out of Ichetucknee Springs State Park
- Extended Rivers Paddle (9 miles)- North launch to William Guy Lemmon Park on the Santa Fe River
- Dampier's Paddle (5.5 miles)- Dampier's Landing upstream paddle to north, return downstream to Dampier's

*I understand that the risk of injury from all activities, including canoe, kayak and SUP rental and shuttle service, involved in this program can be significant, including the potential of personal injury, property damage, or wrongful death resulting from any cause. I also understand and agree with the rental and shuttle rules and regulations as stated above. I hereby release Paddling Adventures, the Cape Leisure Corporation and the State of Florida, Department of Environmental Protection, and Florida Board of Trustees from liability for personal injury, property damage, or wrongful death.*
